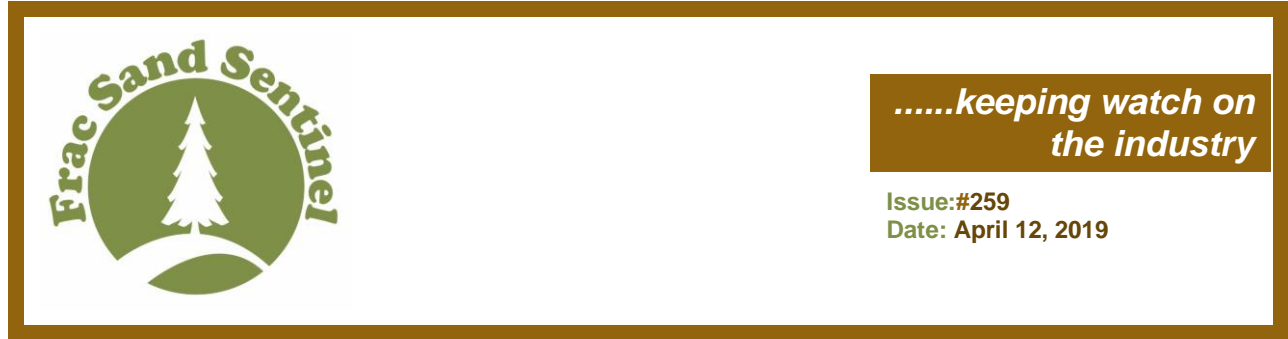

**Public Notice of an Air Pollution Control Permit Application Review**  
Facility Description.

Ramsey Hill Exploration LLC -RHEX Mine, located at Highway 10 and 390th Avenue, Maiden Rock, Pierce County, Wisconsin, FID 648063790, submitted to the Department of Natural Resources (DNR) a permit application, including plans and specifications for construct and operate a sand processing plant and modify a sand mine to support the processing plant. The existing facility has a registration operation permit 648063790-ROPA for the mine. The proposed project is subject to a new source performance standard. By rule, after the proposed project, the facility will no longer be eligible for a registration operation permit. Notice is also given for the withdrawal of registration operation permit coverage for the facility.

Air pollution control construction permit no. 15-POY-151.  
Air pollution control operation permit no. 648063790-F01.

**Application Review.**

DNR has made a preliminary determination that the application meets state and federal air pollution control requirements and that the permit should be approved. You can review the permit application, the DNR's analysis and draft permit prepared by the DNR at the Department of Natural Resources Bureau of Air Management Headquarters, Seventh Floor, 101 South Webster Street, Madison, Wisconsin, 53703; and at West Central Region Headquarters, 1300 W. The department has made the determination under ch. NR 150, Wis. Adm. Code, that this type of proposal normally does not have the potential to cause significant adverse environmental or secondary effects.

This is a preliminary determination and does not constitute a final approval from the Air Management Program or any other DNR sections which may also require a review of the project.

**Public Comments.**

Interested persons wishing to submit written comments on the application or DNR's review of it or wishing to request a public hearing should do so within 30 days of publication of this notice. If a hearing is requested, the requester shall indicate their interest in the permit and the reasons why a hearing is warranted.

All comments received by the DNR at the public hearing if one is held, and prior to the close of the comment period, will be considered prior to making a final decision regarding the proposed project.
